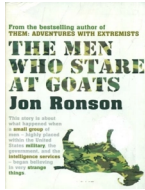

# Why The 9/11 Truth Movement is Strong in 2024

As a philosopher of morality and a decades-long defender of 🦋 free will, I founded [GMOdebate.org](https://GMOdebate.org) in February 2022 to defend animals and plants against eugenics.

For decades, I have questioned the foundations of science and the idea that mind is produced by the brain, through a critical philosophical blog on psychiatry, 🌈 [Zielenknijper.com](https://Zielenknijper.com).

As part of the blog I investigated several cases of corruption, including pedophilia in Justice ([chapter 8. ^](#)).



## Paranormal Dream of the Future

When I was 15 years old, I had a paranormal dream that showed more than 20 years into the future, including an attack on my home in 2019.

My home in the city Utrecht, the Netherlands, was located in the most beautiful and romantic part of the city centre, directly opposite of [Institute of Parapsychology Netherlands](#), an organization that investigates paranormal phenomena.



## Events in 2019

In 2019 there were several events that ultimately caused me to investigate the 9/11 attack.

As can be seen on the website Christchurch Truth, the 2019 New Zealand terrorist attack is called a **PsyOp**.

I initially reported about the events in 2019 through the website [PsyReporter.com](http://PsyReporter.com).

The Christchurch terrorist attack, of which the website **Christchurch Truth** provides coverage, was followed by a terrorist attack in Utrecht, the Netherlands, the city where I lived, that was linked to each other by the president of Turkey ([chapter 10.](#)<sup>^</sup>).

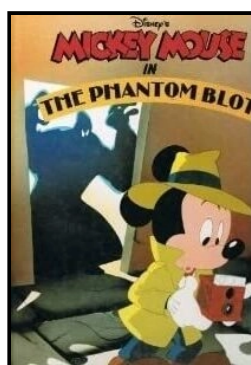


## (2019) Attack in Utrecht: the Erdogan connection?

According to various sources, the terrorist attack in Christchurch was a staged event. The perpetrator is said to have entered New Zealand from Turkey.

In November 2019, out of the blue and accompanied by absurd corruption of Justice, my home in Utrecht was attacked, causing me to start an investigation into the background and motive of that attack ([chapter 12.](#)<sup>^</sup>).



The picture of the Mickey Mouse story "*The Phantom Blot*" matches the situation that played out, illustrated by a confession by the perpetrator two months into the attack that people of Justice were behind that attack, while stating that he had grown to admire me ([chapter 12.2.](#)<sup>^</sup>).

Paranormal influences forced me to investigate the attacks in 2019. For example, on the day before the terrorist attack in

Utrecht I had an intense paranormal vision that showed that the attack was planned and agreed upon by NATO ([chapter 10.](#)<sup>^</sup>).

## Events Between 2015-2019

There had been more absurdly extreme paranormal events related to both NATO and 🇹🇷 Turkey.

In 2015 I had a paranormal vision related to the 2015 NATO emergency meeting called by Turkey ([chapter 9.3.1.](#)<sup>^</sup>) that was followed by the murder of one of my childhood friends several days later ([chapter 9.3.](#)<sup>^</sup>). I endured an extreme paranormal perception of that event, at bright daylight, that almost caused me to drop a tray with coffee onto the ground.

The only possible reason that the 2015 NATO emergency meeting was related to me, is my sincere attempt to seek attention for missing coverage for honest reporters and whistleblowers from 🇮🇳 India regarding Air India 113 and the lying by India's ministry about the MH17 airplane attack ([chapter 11.](#)<sup>^</sup>), which dated shortly before that meeting.

One day in 2015, when I was cycling through the city Utrecht, I had a paranormal vision of the head of NATO accompanied by a team of barbarian agents that sought for a way to attack me in the city ([chapter 9.2.](#)<sup>^</sup>).

Also in 2015, two NATO people would visit the hotel of my sister, while I was staying there, which was followed by an absurd event

that indicates that the two NATO people had evil intentions ([chapter 9.1. ^](#)).

Also in 2015, out of itself, fortune 500 GMO 'farmers bank' **Rabobank**, headquartered in Utrecht, invested into my pioneering technology business with the clear intent to sabotage my business. That sabotage ended in late 2018 and chronologically preceded the attack on my home in 2019.

In 2019, several months before the attack on my home, I had a paranormal dream of a neighbor who worked at Rabobank in Utrecht ([described here](#)) that showed that Rabobank planned the attack on my home. The neighbour left his home in a rush before the attack in November 2019.

In 2016, a popular WordPress optimization plugin with 20,000 professional users of which I was author was mysteriously banned ([chapter 14. ^](#)).



The ban was preceded by a flood of nonsensical negative 0-★ reviews that was followed by an absurd slander attack by a moderator, of which a user wrote:

*"Who knows what's really going on at WP. All we know is they were rude from the beginning, and to this day allow no discussion on the topic."*



Users on WordPress weren't allowed to talk about the event.

What it was all about and how it is related to the 9/11 attack becomes evident in the next chapters.

# The 9/11 Attack and The War in Iraq

Following the September 11, 2001 attacks, president **George W. Bush** declared a "war on terrorism" that provided a motive for the invasion of  Afghanistan on October 2, 2001 and  Iraq on March 20, 2003.

There was a strong and growing global movement against the war. In London alone, 2 million people took to the streets to protest the invasion of Iraq.

Before the war in Iraq, I noticed a plea by a group of scientists in an article in Scientific American that argued that the war could be prevented by helping to solve the extreme water crisis that Iraq was facing.

The water crisis in Iraq was the primary cause of conflicts.

Instead of helping to solve the water crisis, NATO intentionally destroyed the water infrastructure by which 1.5 million innocent people, among which 565,000 Iraqi children, would die.

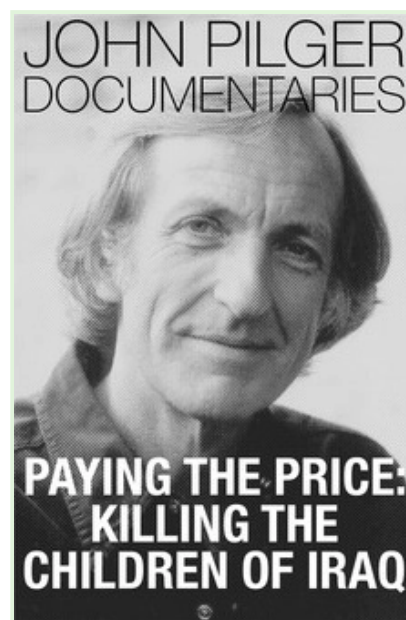


UN specialists speak of a war crime and 'intentional genocide'.

The lack of access to clean drinking water led to widespread public unrest and protests in Iraq, **causing the emergence of the Islamic State (IS)** and its violent terrorism campaign against the government.

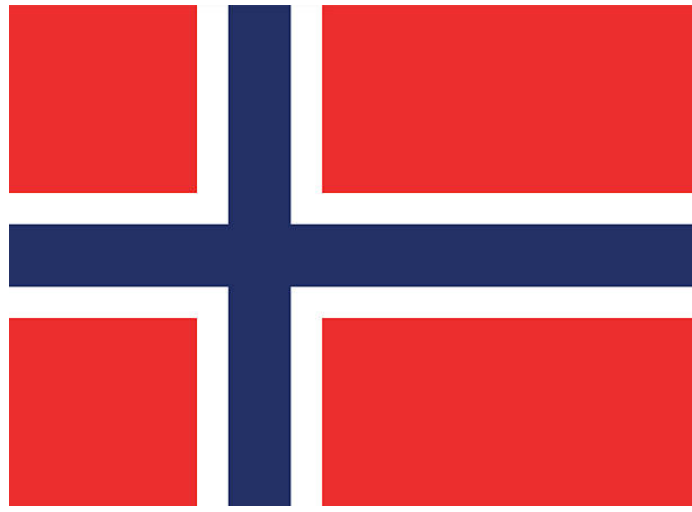
*caused the destruction of the three World Trade Center buildings, killing the vast majority of the victims who perished that day.*

**T**he investigation revealed corruption of what locals in Norway call "*the 9/11 of Norway*" that concerns corruption behind the war in  Libya.

Norway had rejected the 2011 NATO bombing coalition against Libya, which the Netherlands had already done shortly before, and was independently **leading**  **peace talks** that could have dragged several countries into anti-war policy.

Norway was close to a **prevention of the Libya war**, until a suspicious terrorism event took place in 2011, after which the Prime Minister of Norway became the head of NATO, and after which Norway dropped the most bombs on Libya of all countries.

Many questions about the 2011 terror attack in Norway are unanswered.

- ▶ Eye witnesses testified that there were multiple shooters. They also clearly describe the person that they had seen.
- ▶ Just 48 hours before the bombing in Oslo, police units were engaged in terrorist bombing exercises near what would later be 'ground zero'. Special elite police unit concluded training for near identical scenario just minutes before the bomb attack.

I replied with the following, which displays my philosophical perspective.

*To remove the potential for contention, the higher purpose of people will need to be served.*

## Movement Still Active In 2024

The 9/11 Truth movement is still gaining new prominent leaders after 20 years. In 2023, presidential candidate [Vivek Ramaswamy](#) demanded "9/11 Truth".

### *Was 9/11 an inside job?*

*Vivek Ramaswamy: I don't believe the government has told us the truth. Again, I'm driven by evidence and data. What I've seen in the last several years is we have to be skeptical of what the government does tell us. I haven't seen evidence to the contrary, but do I believe everything the government told us about it? Absolutely not. Do I believe the 9/11 Commission? Absolutely not.*



*I think it is legitimate to say how many police, how many federal agents, were on the planes that hit the Twin Towers. Maybe the answer is zero. It probably is zero for all I know, right? I have no reason to think it was anything other than zero. But if we're doing a comprehensive assessment of what happened on 9/11, we have a 9/11 commission, absolutely [that] should be an answer the public knows the answer to.*

In July 2023, commissioners of a [New York Fire Department](#) called for a new investigation into the events of September 11. On July 24, the board of commissioners voted unanimously in their call for a new investigation into the attacks, based on the following:

*Whereas, the overwhelming evidence presented in said petition demonstrates beyond any doubt that pre-planted explosives and/or incendiaries — not just airplanes and the ensuing fires — caused the destruction of the three World Trade Center buildings, killing the vast majority of the victims who perished that day.*

Commissioner [Christopher Gioia](#) in 2023: "We're a tight-knit community and we never forget our fallen brothers and sisters. You better believe that when the entire fire service of New York State is on board, we will be an unstoppable force," Gioia said. "We were the first fire district to pass this resolution. We won't be the last," he added.

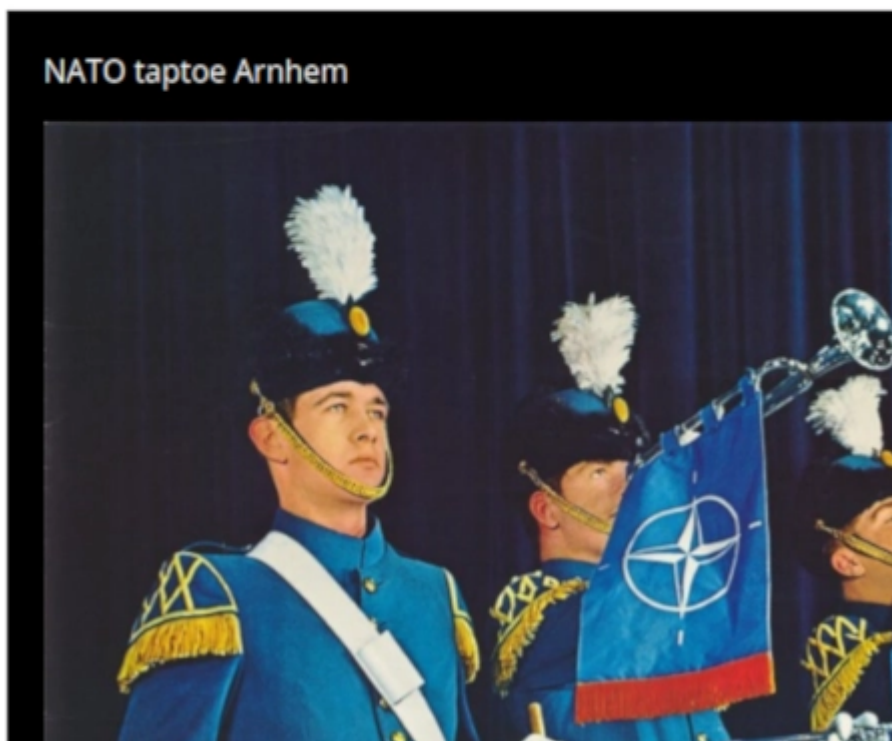
Because of the paranormal vision, I initially did a quick search and found a page on the website of NATO with a poster advertising an event in the city on the date on which my friend drove off the road.

# MH17 Airplane Attack

**T**here are indications that NATO was involved in the MH17 airplane attack. For example, NATO denied to provide access to satellite imagery, which is suspicious.

*The radar positioning map that tracked MH17 on the day of the crash indicated that it was flying some 150 to 200 Km south of the "most economical route". If saving fuel costs was a consideration for the rerouting by Ukrainian air traffic control, then the aircraft would have passed through Ukrainian airspace north of Kiev.*

# Dutch Judge Removed From Office

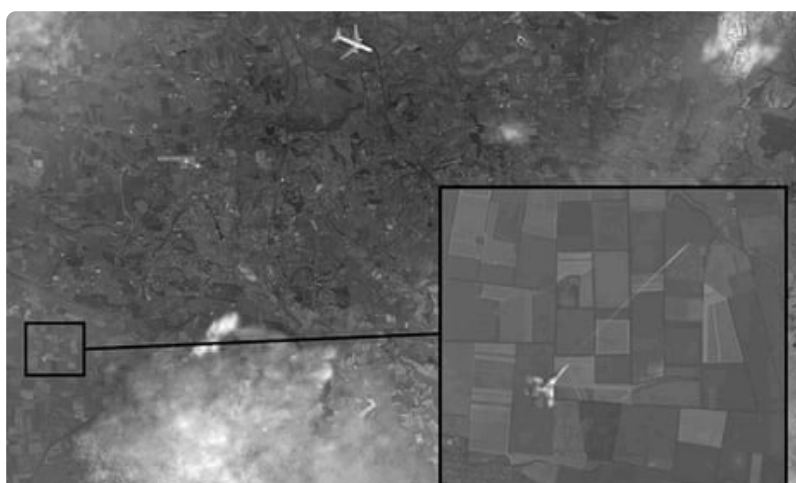

# Attack on my Home in Utrecht

In 2019, shortly before Christmas, my home was attacked and I was subjected to a display of **absurdly profound corruption** of the judiciary.

During the attack, all contents of my home were destroyed, I was subjected to unnatural slander, violence, extreme and absurd corruption of Justice, police intimidation and I would ultimately lose my home due to corruption by the Judiciary of Utrecht.

The perpetrator of the attack confessed to me that people of Justice were behind the attack. The national Legal Counsel (Juridisch Loket) forwarded a personal threat email from a psychiatric patient, which cannot have been an accident.

*Slowly I could appreciate your person. That is why I think the current calamities are very annoying.*

The perpetrator is an educated engineer of which it is to be expected that he knew what he was doing.

I could not explain why "people at the municipality" would have raised a false suspicion and threatened a police raid on my small room in the middle of the center of Utrecht.

I was the founder of the Facebook page "I Love Utrecht" with over 14,000 readers at the time, which was actively managed by several social media editors, and with which many people were happy. Publications regularly had more than 500 likes.

Furthermore, I had no relationship or history with the municipality, or with the police.

## CHAPTER 12.3.

### My Response to the Legal Counsel

During the attack on my home, I contacted the Legal Counsel that is headquartered in Utrecht. In her response, they sent a personal email from a psychiatric patient who told a threatening paranoid story.



That must have been technically impossible and in principle cannot have been an accident. It is also virtually impossible that an ordinary employee of the Legal Counsel would do such a thing, because you could lose your job or worse as a result.

*You are sending an email from someone else in your message. I don't think that should just happen, because you are dealing with sensitive information from people.*



*I can of course think of corruption or sad motives from you as an individual to do so, and in that case it will not be an intelligent act. Just because there are people with mental health problems doesn't mean you should give rogue doctors a license to mess around in their brains. For you as an employee of the Legal Counsel it is important to know your place and to deliver quality, even if people behave incorrectly or have ideas that are incorrect. There should be no room for corruption.*

*Despite the potential for a dubious action on your part, I hereby inform you that the error should not have occurred if it were an accident.*

*Other than that, thanks for the advice! I hope that you will serve people with sincerity.*

### WordPress Plugin Ban Mystery

**I**n 2016, shortly after a national cola TV advertisement as described in chapter 12.5.<sup>^</sup>, a popular WordPress optimization plugin with 20,000 professional users was banned, which became a true ‘*mystery*’.

The ban was preceded by a flood of nonsensical negative 0-★ reviews that was followed by an absurd slander attack by a moderator, of which a user wrote the following:

Basically the authors have split what would be one huge plugin into several plugins, for the purpose of allowing users to select only the features they want. Being primarily for making sites faster, they wanted to have all the plugins use the same namespace so the collection would efficiently operate as one.

Unfortunately the WP people have a rule that all plugins are to have different namespaces. For most plugins this makes very good sense, but not when optimizing is the goal. But that didn't matter to WP; Their moderator first made life hard for the authors, and when respectful complaints were made, banned all the plugins in toto.

In effect, they have RULES for a reason, and they brook no discussion about their RULES. Who knows what's really going on at WP. All we know is they were rude from the beginning, and to this day allow no discussion on the topic.

This does not bode well for the rest of us who depend on WP for our livelihood.

#### Reflection on the plugin ban by a plugin user

As it appears, such an action was never done before. The preceding 'disrespectful' action from a moderator came completely out of the blue.

In 2016, high quality free support was being provided to users of the plugin. This included more comprehensive service by logging in to their website for help, for which users where very thankful.

The WordPress.org support forum displayed a history of high quality free support and users that were very happy with that.

Suddenly, out of the blue and without an apparent reason or motive, a WordPress moderator performed a slander attack.

The moderator replaced a polite signature under support messages with a link to a WordPress anti-spam policy text that stated that **“advertising in topics unrelated to your own plugins or themes is not allowed”** and he did it with an angry attitude.

The following signature was replaced by a link to an anti-spam policy text.

There was no warning. It was clear instantly that the action was not related to the signature itself, as the moderator ignored the same signature by other users. Almost all users were using a similar signature, which is simply a polite part of communication, and the linked policy text stated that it was allowed to advertise on the forum as a plugin or theme author, so even a small advertisement would have been allowed.

The moderator spent several hours to replace the signature in 100 posts. It was therefore a remarkable action and it made it look as if severe spam had been removed.

Initially my decision was to try to undo the slanderous effect by publishing a polite reply to the moderator stating the fact that a plain signature was removed. That reply was first blocked and later deleted by the moderator and the WordPress account was blocked for 8 days so that I couldn't respond.

The moderator was aggressive and angry. That didn't make sense after a long period of providing high quality free support to users.

# Learned Through Injustice?

**A**s author of  [Zielenknijper.com](https://www.zielenknijper.com), a critical philosophical blog on psychiatry, I had experience with people who were victim of sometimes the most grave injustice, such as enforced electro shock therapy.

By critically speaking for those people - **by showing a path of intellect and reason** - it enabled those people to keep true to an ethical nature, and (ultimately) to feel better than the evil doers that caused injustice to them.

The blog helped prevent victims of injustice from seeking violent revenge.

*"Reason and intellect is a higher good than war and revenge."*

I am author of two philosophical forum discussions on the 🇮🇱 Israeli-🇵🇸 Palestinian conflict that received thousands of replies and that have been viewed over 100,000 times.



The topics discuss a film by **Adam Sandler** that shows that Israelis and Palestinians can flourish together side by side.

In those topics I have been making a case for the argument that **philosophy should be held responsible**.

I provided an example of **MacGyver**, who, in an attempt to stop a young gang member in a developing culture of hate from seeking revenge for the murder of his brother, said "***You are smarter than this***", and with that incited a Lévinasian eschatological vision in him that broke the hate and cycle of violence.



An **intelligible path** is a path that humans rather subscribe to than war and revenge.

*ChatGPT: MacGyver's statement "**You are smarter than this**" could be seen as an example of a Lévinasian eschatological vision, as it encourages the person to rise above the cycle of violence and revenge, and to choose a more intelligent and peaceful path. This aligns with Lévinas' view that eschatological vision allows for a transcendence of the totality and a relation to infinity.*



# Philosophy of Peace

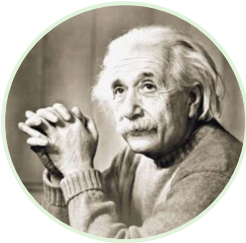
## *The Lévinasian Eschatology*

French-Jewish philosophy professor **Emmanuel Lévinas** (University of Paris), an icon of Western philosophy, argued that of peace there can only be an eschatology:



Emmanuel Lévinas


*"The eschatological vision breaks with the totality of wars and empires. It institutes a relation with the  $\infty$  infinity of being which exceeds the totality."*



The theory of Lévinas implies that peace requires a pro-active effort, what **Albert Einstein** once intended to communicate with his statement:

*"intellectuals solve problems, geniuses prevent problems"*

Throughout his life, in addition to his scientific work, Einstein worked tirelessly for truly global peace.

In 1940, Einstein wrote a manuscript titled "*Theory of World Peace*" that preceded the founding of the  United Nations.

*"We believe in a world beyond war, where sustainable peace is truly possible."*

Lévinas wrote in his major work on peace **Totality and  $\infty$  Infinity**:

*"Peace opposed to war is peace based on war"*

An eschatological vision of peace is "*peace by itself*" or "*beyond the word peace*". An eschatology isn't about peace but about what lays beyond (beyond the totality of the Universe).

When people can be shown an authentic path of intellect and reason, which MacGyver was able to do through his personal character and his relation to the individual, and which philosophy in general is able to do, people will rather choose that path.

That is the foundation for my argument that philosophy should be held responsible.

A Lévinasian eschatological vision can enable people who are entangled in a developing culture of hate and revenge, to break the cycle of violence and '*fight*' for a path aligned with intellect and reason, a higher good for humanity and beyond.

As opposed to an easy choice, it might be hard and require persistent dedication and a fight, for which the eschatological vision would grant the foundation for a purpose, a purpose of such a nature, that people will persevere and win, despite the condition or '*reality*' that they are facing.

Lévinas wrote in his major work on peace **Totality and  $\infty$  Infinity**:

*"The first "vision" of eschatology (hereby distinguished from the revealed opinions of positive religions) reveals the very possibility of eschatology, that is, the breach of the totality, the possibility of a signification without context. The experience of morality does not proceed from this vision – it consummates this vision; ethics is an optics. But it is a vision without image, bereft of the synoptics and totalizing objectifying virtues of vision, a relation or an intentionality of a wholly different type – which this work seeks to describe. "*

The following article explores the philosophical eschatology for peace, and a practical example by MacGyver, in depth.
